You may now submit your application and pay the processing fee online! You may choose this option upon completion of your application.

A non-refundable application processing fee of \$50 per application will be charged and must be included at the time of filing the application, whether you file online or complete a paper form.

If you file online, payment must be made with a credit or debit card. If a paper application is filed, acceptable forms of payment are check or money order, payable to: County of Alameda. If your check is returned due to insufficient funds, a returned check fee in the amount of \$25 will be charged for the first returned check, and a fee in the amount of \$35 will be charged for a second returned check. **Applications submitted without the fee will not be processed.**

Electronically submitted applications are not valid and will not be submitted or processed until electronically signed and the processing fee is confirmed. **The electronically signed application and payment MUST be received by the filing deadline or your application will be rejected as untimely.**

Paper applications are **not valid** and will not be processed until a signed original and payment for the non-refundable application processing fee of \$50 per application are received by the Clerk of the Board, Assessment Appeals Unit or postmarked within the filing deadline. Also, please mail the signed original and one copy to the Clerk of the Board, Assessment Appeals Unit and retain one copy for your records.

Specific instructions for completing your application will be provided when you have completed your online form.

Note: The Regular Assessment Appeal Filing Period is JULY 2 and SEPTEMBER 15 unless September 15 falls on a weekend, in which case appeals are due on the next business day. This year, applications filed in person or electronically using this system **must be filed by 5:00 P.M. PST on SEPTEMBER 15, if you are unable to complete your application online or deliver it in person to the Clerk of the Board, Assessment Appeals Unit by 5:00 P.M. PST on September 15, alternatively, applications may be filed by mail and must be postmarked by 11:59 P.M. PST on September 15.**
